From the Executive Director



Kentucky Underground Protection, Inc. is approaching its 40-year anniversary of leading the underground utility damage prevention and excavation safety efforts in Kentucky. Yet 2023 was a year of many firsts. It was also a record setting year for 811 locate request activity. The corporation was rebirthed following the separation from Underground Safety Alliance and firmly established a standard for safety within the communities and neighborhoods of Kentucky.

Following the separation from Underground Safety Alliance, Kentucky Underground Protection, Inc., d.b.a. Kentucky 811, restructured corporately and put in place the foundations to build a world-class utility damage prevention and excavation safety organization. The year 2023 was the first full year of our partnership with One Call Concepts to provide contact center services. It was also the first year working with our network of business partners: Goforth & Herron, Dean Dorton, Stablemate Creative, SimplifiT, Hawkins HR Consulting and Design Web Louisville. This network of service providers was outstanding and performed with precision and professionalism.

It was the first year for our new staff. We added two damage prevention managers and a business manager. Jamie Gaddis is Damage Prevention Manager for the eastern part of the state, and Patrick Donoghue is Damage Prevention Manager for the western part of Kentucky. Diane Bischoff is Business Manager and works closely with the board of directors and with me on corporate issues.

Operationally, we had several firsts. Volumes for 2023 exceeded those for 2022 all twelve months. Nine of the months were all-time "history of the company" records. We surpassed 80% online web locate request entry for the first time ever. We outperformed our key performance indicators in every category. The average speed of answer was faster than our target of 60 seconds for all twelve months and was less than 30 seconds for four of the months.

We built efficiencies into the mapping system and web entry drawing tools that greatly rewarded our member utilities. These efficiencies returned hard dollar savings by reducing the number of locates that we transmitted by over 300,000. That's not only a monetary savings, it is removing a lot of unnecessary locates from the already stressed system.

We are in the process of building a new public facing website that will replace the current www.kentucky811.org. This was the first year that we operated an online promotions store that provided easy access to order giveaway items that promote Kentucky 811 and safe digging. Additionally, we built an internal intranet site for electronic storage of corporate documents.

Another first for 2023, we established a pilot scholarship program through the Kentucky Technical College System, Owensboro Campus. Two scholarships will be awarded annually to students entering the technical college system to learn a construction related trade. To be eligible, the students must be related to an employee working for one of our member utility operators.

As a result of the excellent strategic direction and leadership provided by the Board of Directors, Kentucky Underground Protection, Inc., is financially sound, has excellent controls in place, is structurally solid and positioned for many more years of overwhelming success.






Kentucky 811 has 474 unique utility operator members. This member base operates 769 utility services (many utility members operate multiple utility types).





Web Ticket Entry


Online locate requests (Web Ticket Entry) is the most efficient way for an excavator to communicate precise information to the utility locator. Our online system called ITICnxt has several drawing tools that allow the requesting excavator to draw their project directly on the map. This drawing is available to the locator for use in the field during the locate process.

During 2023 Kentucky 811 and One Call Concepts conducted six "software summits" throughout the state to train excavators on the use of the online request entry tool.


Web Ticket entry volumes increased during 2023 and accounted for 74.7% of all locate requests.

Outbound Transmissions


Notifications sent from Kentucky 811 to Members to be located.



Outbound Ratio


Outbound ratio is an average of how many transmissions are sent to our members for every inbound request we receive. The ratio dropped during 2023 because of Kentucky 811 having more accurate base maps with the purchase of county parcel data and the increased use of the online web ticket entry system which allows the excavator to be precise about where they intend to excavate. The result was a reduction in locate requests that would have been transmitted to our members that were not in the proposed excavation area provided by the requesting excavator.

Improved mapping

- Built-in tools to alert the KY811 GIS team to add new areas and roads to the maps.
- Parcel data added to maps is used to narrow scope of work to single addresses from block to block
- Continual map improvements used to reduce mapping of excavation areas during the ticket taking process
- Precise and accurate mapping has an impact on the number of tickets sent to member utilities saving them time, money, and resources.

New enhanced online ticket processing

~80% of tickets are processed online.

- Ability to process all ticket types online
- Excavators can precisely map their excavation sites online using multiple enhanced mapping tools. Access to the interactive maps showing the precise excavation sites is sent to the members and locators on each ticket.
- Scheduling tool allowing excavators the ability to process tickets in advance and release them when they are ready for marks.
- Each ticket confirmation includes educational information about the KY811 process as well as an interactive link allowing all excavators (professional and homeowners) the ability to take additional actions (request remarks, see positive response, etc.).



Self-service options through the phone system allow excavators the ability to process remarks without speaking to a call center representative.




